And RCW 42.30.110 (1) (g) To review the performance of a public employee. However, subject to RCW 42.30.140 (4), discussion by a governing body of salaries, wages, and other conditions of employment to be generally applied within the agency shall occur in a meeting open, and when a governing body elects to take final action hiring, setting the salary of an individual employee or class of employees, or discharging or disciplining an employee, that action shall be taken in a meeting open to the public. Action may or may not be taken after Executive Session.

Joining the Board in Executive Session will be HR Supervisor Sherese Gamble, Executive Secretary Lauri Perry and Legal Counsel. We will convene into Executive Session until 1500 hours.

At 1430 hours Commissioner Vadino rejoined Executive Session.


At 1500 Executive Session was extended until 1505 hours.


At 1505 hours the Special Meeting reconvened. Commissioner Baruso announced that we are out of Executive Session.


**ESTABLISH WRITTEN EXPECTATIONS OF THE FIRE CHIEF**
